QUARTERLY REPORT TO 30 SEPTEMBER 2017

HIGHLIGHTS

- Preparation for Medcalf Project primary environmental approval continued.
- Medcalf Drill programmes designed and submitted to DMIRS for approval.
- Gascoyne Project sold.

Audalia Resources Limited (ASX: ACP) is pleased to present its report for the September 2017 quarter.

MEDCALF PROJECT

The Medcalf Project is a vanadium-titaniumiron project located some 470 kilometres south east of Perth near Lake Johnston, Western Australia. The Medcalf Project comprises two granted Exploration Licences E63/1133 and E63/1134 as well as mining lease M63/656. Together these licences covering a total area of 24 km².

The Medcalf Project lies in the southern end of the Archaean Lake Johnston greenstone belt. This greenstone belt is a narrow, northnorthwest trending belt approximately 110 km in length. It is located near the south margin of the Yilgarn Craton, midway between the southern ends of the Norseman-Wiluna and the Forrestania-Southern Cross greenstone belts.




Figure 1: Medcalf Project - Location Map



Interim metallurgical testwork programme

The interim metallurgical testwork programme was completed in the June 2017 quarter with the testwork report finalised by the independent overseas consultant with some additional confirmatory and repeatability testwork results during the September 2017 quarter.

The results following receipt of the final report for this testwork were released to the market on 26 October 2017.

Environmental approval

The preparation of the primary environmental approval documentation continued during the September 2017 quarter. A pre-referral meeting was held with the state Environmental Protection Authority (**EPA**), and the Medcalf Project was introduced. It is envisaged that the primary environmental approval application will be submitted during the December 2017 quarter.

Programmes of Work Submission

During the quarter, the Company submitted two programmes of work (**POW**) to the Department of Mines, Industry, Safety and Regulation (DMIRS), one for sterilisation drilling over the proposed mine layout area and the other for regional exploration east of the Fuji deposit.

GASCOYNE PROJECT

Tenements E09/1568, E09/1569 and E09/1570 were surrendered during the September 2017 quarter. The Final Surrender Technical Report and the Operations Reports for each tenement were compiled and submitted to DMIRS.

The Company announced on 7 August 2017 that the Gascoyne Project, comprising of tenements E09/1824, E09/1825 and E09/2102, was sold to Serena Minerals Pty Ltd.

CORPORATE MATTERS

The Company also continues to actively review and assess other projects in the resource sector, both in Australia and overseas, by way of acquisition or investment/joint venture.
